### ICBC Issues Revised APV9T Form

Due to a request from the Consumer Taxation Branch (CTB), the Transfer/Tax Form (APV9T) has been reformatted. A new field – SELLING PRICE – has been added to the seller's section. As a result, some of the fields in the top portion of the form have been repositioned.

The DATE OF SALE field has been moved to a different spot to make room for the SELLING PRICE field right above the seller's signature, as shown below:

The new SELLING PRICE field is for private sellers. It does not need to be completed by dealers. However, dealers that use software to print data will need to adjust their programs to accommodate the new form.

### ICBC Announces New Salvage Buying Agreement

ICBC has introduced a new salvage buying agreement, which will take effect on April 1, 2014. The agreement includes new salvage buying policies and requirements related to removal of salvage, fees, access to email and the protection of personal information. It also provides clarity regarding actions that would warrant termination or suspension of an agreement.

#### Important changes to buying categories

The body shop, general public company and general public individual buyer categories will be discontinued. There will be just three buyer categories: 1) rebuilder/dealer, 2) wrecker/dismantler/recycler and, 3) educational institution. Buyers currently registered under the discontinued categories must obtain a Motor Dealer Licence from the Vehicle Sales Authority and meet the minimum requirements outlined in the new agreement to continue purchasing salvage.

#### Action needed

As of April 1, 2014, current agreements will no longer be valid. A signed copy of the new agreement must be submitted to ICBC no later than March 31 at 10 a.m. Buyers who do not submit an agreement by this date will be unable to purchase salvage from ICBC until a new agreement is submitted.
