UNDERTAKING

(Section 154, Business Practices and Consumer Protection Act)

WHEREAS the undersigned Stephen Nuttall, who has a lapsed Motor Vehicle Sales Authority (previously known as the Motor Dealer Council) salesperson license and previously employed by AutoCanada Hometown Motors GP Inc A General Partner Hometown Motors LP doing business as Victoria Hyundai is a "supplier" within the meaning of subsection 1(1) of the *Business Practices and Consumer Protection Act*;

AND WHEREAS the Registrar of Motor Dealers (the "Registrar") has reason to believe that the supplier is contravening is about to contravene or has contravened the *Business Practices and Consumer Protection Act* (BPCPA) or the regulations made thereunder, namely:

It is alleged that between July 10, 2009 and September 9, 2009 the conduct by the supplier in the retail sale of motor vehicles resulted in several consumers complaining that motor vehicles purchased for their personal and family needs did not meet all the statutory requirements for the sale of motor vehicles as expressly or implicitly represented by the supplier.


AND WHEREAS the undersigned is desirous of resolving this matter without the need for any formal adjudication of the above allegations.

AND WHEREAS, the undersigned's previous employer AutoCanada Hometown Motors GP Inc A General Partner Hometown Motors LP doing business as Victoria Hyundai has resolved the consumer monetary complaints to the satisfaction of those consumers and the Registrar.


NOW THEREFORE the undersigned hereby undertakes to not apply to the Motor Vehicle Sales Authority of BC previously known as the Motor Dealer Council of BC for a Salesperson Licence in British Columbia for a period of two (2) years from the date of the signing of this Undertaking; and

THE UNDERSIGNED hereby acknowledges, represents and declares that he has read this Undertaking and has had a reasonable opportunity to obtain independent legal advice as to its terms.
